# Exhibit "A" Scope of Services

#### PROJECT DESCRIPTION:

This project includes the construction of an approximately 16,500 square foot aircraft maintenance facility which includes the following: a 12,000 square foot Hangar, 3,000 square foot Office, 1,500 square feet of Storage Space, an associated Aircraft Apron, Vehicle Parking Lot, and security elements with both landside and airside connections to the hangar.

The aircraft maintenance facility will be a pre-engineered metal building that includes all structural, mechanical, electrical, plumbing, and fire protection systems. Engineering and permitting for this project is being completed by AtkinsRealis USA, Inc. under a separate Task Authorization.

Final design elements are still to be determined and may include additional civil, utility, information technology and other building components. It is understood that AtkinsRealis USA, Inc. will be working with Lakeland Linder International Airport Staff on the final design.




FIGURE 1: PROPOSED HANGAR / OFFICE / STORAGE LAYOUT
