Regular Session January 2, 2024

The Lakeland City Commission met in Regular Session in the City Commission Chambers.

CALL TO ORDER - 9:00 A.M.

Mayor Bill Mutz explained that Commissioner Sam Simmons resigned effective December 30, 2023, to avoid the Form 6 requirement and would not be attending today.

MOTION TO ADJOURN SINE DIE

Motion: Commissioner Mike Musick moved to adjourn Sine Die. Commissioner Sara McCarley seconded.

Mayor Bill Mutz asked for comments from the Commission and the audience. There were no comments.

Proposed 24-001; Proposed Text Amendment CPA23-004 to the Lakeland Comprehensive Plan to Expand Transit Oriented Corridors in the City of Lakeland

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKELAND, FLORIDA RELATING TO LOCAL GOVERNMENT COMPREHENSIVE PLANNING; PROVIDING FOR TEXT AMENDMENT CPA23-004 TO THE LAKELAND COMPREHENSIVE PLAN: OUR COMMUNITY 2030; AMENDING CHAPTER 2 OF THE COMPREHENSIVE PLAN TO REVISE MAP FLU-7, TRANSIT ORIENTED CORRIDORS; MAKING FINDINGS; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

Palmer Davis read the title.

Urban Planning and Transportation Manager Chuck Barmby presented on both ordinances. These changes were requested to take advantage of development in Downtown West and the central core area. He explained the change in definition of a Transit Oriented Corridor (TOC). He then reviewed the staff recommendation for the 2 ordinances.

The Commission discussed:

- Sidewalks versus Trails.
- The effect on the Citrus Connection. Since LAMTD is a separate governing body, they are not compelled to make changes to their routes. It does support LAMTD changes to routes and services.
- Density on the expanded corridors: Density depends upon infrastructure availability in the area. It boils down to concurrency and parking.
- These changes align the City, TPO, FDOT and the transit authority. Chuck Barmby works well with those entities to ensure safe pedestrian traffic to transit stops.

Proposed 24-003; Amending Ordinance 4850; Major Modification of PUD (Planned Unit Development) Zoning in Order to Adopt a New Master Plan for the Florida Baptist Children's Home Property Located at 1015 Sikes Boulevard

AN ORDINANCE RELATING TO ZONING; MAKING FINDINGS; AMENDING ORDINANCE 4850 TO PROVIDE FOR A MAJOR MODIFICATION OF PUD (PLANNED UNIT DEVELOPMENT) ZONING IN ORDER TO ADOPT A NEW MASTER PLAN FOR THE FLORIDA BAPTIST CHILDREN'S HOME PROPERTY LOCATED AT 1015 SIKES BOULEVARD; PROVIDING CONDITIONS; FINDING

The foregoing is the title of an ordinance read for the first time by short title only. The Commission will hold the second reading and public hearing on January 16, 2024.

Chuck Barmby gave a presentation on the ordinance.

The Commission discussed:

- Mayor Bill Mutz on parking: The parking was reduced because it is part of a larger campus. It was not treated the same as a standalone development. These changes would not have a big impact on resources. They have a nonbinding concurrency certificate from the school board. They will be subject to capacity review by water and wastewater utilities.
- Commissioner Bill Read on density: The project will be complete around 2030. Staff did not know the total density. There was a substantial amount of open space on the project.
- Commissioner Mike Musick: How did tearing down and adding new buildings affect the decision making? What are the criteria to permit the taller buildings. Chuck Barmby explained in this case it is geared towards the applicant's needs. They are serving a larger community demand. The City is responding to their requests. Through the public hearing process, the City learns if there are concerns from the surrounding property owners. It is not a new development because they have existing buildings on site. The review impacts are considered the net difference between the existing and the new.
- Commissioner Chad McLeod: Requested someone from Florida Baptist Children's Home attend the public hearing and explain their master plan and their impact in the community.

The following two ordinances were related to property at the northeast corner of Florida Ave. and Glenwood Dr. The land use change was from BP to RH. The max development potential was 292 units. The developer was looking at 150.

Proposed 24-004; Small Scale Amendment #LUS23-002 to the Future Land Use Map to Change Future Land Use from Business Park (BP) to Residential High (RH) on Approximately 3.9 Acres Located at 3601 N. Florida Avenue

Waiver of 5:01 p.m. Hearing Requirement

During the month of January, the City Commission will be presented a Text Amendment to the Lakeland Comprehensive Plan and the Land Development Code which will require at least one hearing after 5:00 p.m.

Staff requested that the Commission waive the statutory requirement that at least one of the hearings on these matters be held after 5:00 p.m.

Palmer Davis presented this item to the Commission.

Motion: Commissioner Sara McCarley moved to approve the recommendation. Commissioner Mike Musick seconded.

Mayor Bill Mutz asked for comments from the Commission and the audience. There were no comments.

Action: Mayor Bill Mutz called for the vote and the motion carried unanimously.

FINANCE DIRECTOR

Appropriation and Increase in Estimated Revenues - Transportation Fund

The City of Lakeland executed a Local Agency Program (LAP) agreement with the Florida Department of Transportation (FDOT) for the design, construction and

Construction Engineering and Inspection (CEI) services for Three Parks Trail West project on June 19th, 2020.

The LAP Agreement (441844-1-38/58/68-01), reimbursed the City in the amount of \$43,200 for the Design Phase and provides funding in the amount of \$305,200 for Construction and CEI services. The Three Parks Trail West project consists of approximately 0.60 miles of a 10-foot-wide shared use path along the east side of Cleveland Heights Blvd, connecting the current Three Parks Trail south terminus near Robin Road to Westover Street. The Three Parks Trail West segment will complete the overall 3.6-mile loop of the Three Parks Trail system, which is an important component of the City's Lake-to-Lake Bikeway and is also identified as part of a designated pathways corridor in the Citywide Pathways Vision Plan.

The City's Public Works Engineering department recently completed the design phase with federal funds administered by the FDOT. The City's Public Works Department has received approval from FDOT to utilize in-house staff for construction and CEI. Construction is anticipated to begin in January and will be completed during summer of 2024.

Staff requested that the City Commission authorize an appropriation and an increase in estimated revenues in the amount of \$305,200 within the Transportation Fund for Construction and CEI Services (\$262,000 for Construction, and \$43,200 for CEI services) for the Three Parks Trail West project.

Mike Brossart presented this item to the Commission.

Motion: Commissioner Bill Read moved to approve the recommendation. Commissioner Stephanie Madden seconded.

Mayor Bill Mutz asked for comments from the Commission and the audience. There were no comments.

Action: Mayor Bill Mutz called for the vote and the motion carried unanimously.

Peterson Park:

Mayor Bill Mutz asked about progress on the Peterson Park repair quotes. Shawn Sherrouse will gather the information and give an update for the Commission.
